

2027 BOMA/Chicago Local TOBY Awards Application Process



THE OUTSTANDING BUILDING OF THE YEAR (TOBY) AWARD is the most prestigious and comprehensive program of its kind in the commercial real estate industry. The TOBY awards recognize excellence in building management, operational efficiency, tenant retention, emergency planning and community impact. The competition begins with the local BOMA/Chicago awards. Local winners will be announced at the TOBY/Gold Circle Awards Gala in early 2027.

For an opportunity to win a BOMA International TOBY Award, a property first must earn the BOMA 360 designation and win both local and regional competitions. Whether winning at the local, regional and/or international levels of the competition, you gain the opportunity to showcase your building's strengths and gain recognition for best-in-class operations and management. Judging is based on criteria that includes community impact, tenant and employee relations programs, energy management, accessibility, emergency evacuation procedures, building personnel training programs and overall excellence.

TOBY LOCAL CHICAGO DEADLINE

The deadline to submit your application is September 17 at 5PM (CST). This deadline will not be extended.

CHICAGO BUILDINGS HAVE A STRONG HISTORY OF WINNING THE INTERNATIONAL TOBY!

Since 2010, [22 Chicago buildings have won the International TOBY Award](#). Our Chicago buildings are truly the best of the best who continue to win at the International level and we encourage you to apply for the 2027 TOBY!

ARE YOU APPLYING FOR THE 2027 TOBY?

If you are applying for a 2027 TOBY, your first step is to contact Jaclyne Madden at jmadden@bomachicago.org. Please let Jaclyne know as soon as possible that your building will be applying so that she can tell you about important and brand-new changes for this TOBY season.

BOMA 360 REQUIREMENT FOR TOBY

TOBY applicants must have the BOMA 360 designation. If you plan to apply for a TOBY this year, you will need to apply and/or maintain your BOMA 360 certification by the September 17 TOBY deadline.

LEVELS OF COMPETITION

The TOBY competition consists of three levels. The first level is held locally by local BOMA associations (BOMA/Chicago). Buildings that win at the local level advance to the regional level. When (and if) a building wins at the regional level, that winner advances to the international level. The Chicago winners will go on to compete in the North Central Region TOBY Awards in March/April 2027. Regional TOBY Award winners compete in the International TOBY Awards. International winners will be announced at BOMA International's annual conference in June 2027.

TOBY FEES

To enter the local TOBY awards competition, you must first pay the \$300 entry fee directly to BOMA/Chicago. Visit this webpage to pay the 2027 TOBY fee: <https://members.bomachicago.org/ap/Events/Register/lzFZMGXTQF5Cw>

If you proceed to the regional competition, you will pay another fee of \$450 (directly to BOMA International). This \$450 will be collected once the entry has been completed and the “Submit” button has been pressed. No additional fees are collected for the international competition.

LOCAL ONLINE/WRITTEN APPLICATION PROCESS

Local TOBY applications must be submitted electronically to BOMA/Chicago through the BOMA International TOBY application portal: <https://recognition.boma.org/>.

We recommend that you save your application within a Word document before you submit your application. Thoroughly review and edit the Word document application before you finalize it. Once the application is finalized, visit the online portal and copy and paste in your answers. Also, please have all of your attachments organized and ready before you fill out the online application form.

TOBY CATEGORIES

Below are the 19 different categories in which you may apply (you can only apply in one of the 19 categories).

- 100,000 to 249,999 Square Feet
- 250,000 to 499,999 Square Feet
- 500,000 to 1 Million Square Feet
- Over 1 Million Square Feet
- Suburban Office Park - Mid-Rise
- Suburban Office Park - Low-Rise
- Corporate Facility
- Earth
- Historical Building
- Industrial
- Life Sciences Building
- Medical Building
- Mixed-Use
- Public Assembly
- Renovated Building
- Retail – Enclosed Mall Under 1 Million Square Feet
- Retail – Enclosed Mall Over 1 Million Square Feet
- Retail – Open Air/Strip Mall

TOBY ENTRY REQUIREMENTS

The online application follows the exact questions, attachments and requirements for your category as written in the Entry Requirements.

SCORING OF PORTAL/WRITTEN APPLICATION

Your assigned TOBY judges will sign onto the portal to review and grade your online/written application. After the January/February 2027 Gala, you will be able to see the comments from your judges. The same judges who review your online application will come to your building inspection. Judges will not grade your inspection online. Judges will complete hard copies of the inspection sheets.

BUILDING INSPECTION & INSPECTION GRADING SHEETS

Inspections will be held in-person at your building between October 12 through November 13. You will be assigned your inspection date in early October. Once you begin the application process, we will communicate more detailed information about the inspections. Please contact Jaclynne Madden at jmadden@bomachicago.org to get a copy of the inspection sheet for your specific category.

Another form, besides the inspection and judging forms, will also be used this year – the TOBY Inspection Verification Form. You can view and download the verification form here:

You will only need to submit the Inspection Verification Form if you proceed to the regional/international competition. If you proceed to these levels, BOMA/Chicago will provide you with a signed Inspection Verification Form to attach to your regional/international application.

DISCLOSURE OF CONTRIBUTORS

All TOBY applicants will be required to disclose, as part of the local application, the name and employer of each person who contributed content, photographs or graphics to the application. Applicants will also be asked to confirm that contributors have granted permission for their contributions to be included as part of the application process and that the contributions do not infringe on the intellectual property rights of any other person.

Failure to provide full disclosure of contributors or any infringement of application material on the intellectual property rights of others may result in sanctions imposed by the Association, including disqualification of the application.

Your building must complete this online form by September 17 at 5PM (CST).
